Reading

Children should read every day for at least 10 minutes at home. Reading for pleasure books can be changed as frequently as needed. Reading Records should be completed at home and are checked regularly in school.

Extra - Curricular Clubs

All clubs, Breakfast Club and extended hours started this week. Children have been allocated spaces - please contact the office if you have any queries around this. As notified, clubs on Friday are cancelled due to the Eid Fair, with the exception of Firefly Club.

Attendance

Being in school is vital for children's education and for their wellbeing. All children are expected to attend school every day unless they are unwell. Last term, our attendance was 94.86%, which is slightly below our 96% attendance target. School attendance is mandatory and we are all working hard to achieve our target. Please be aware that:

- It is a parent/carer's duty to ensure that their child attends school.
- It is the schools' responsibility to record attendance and follow up absence.
- Schools and local authorities may issue sanctions, including fixed penalty notices in line with local authorities' codes of conduct if a child is absent from school.

Punctuality and the School Day

If your child attends breakfast club or a morning club, please ensure they are not brought to school too early. They all start at 8am.

Please note, if your child arrives after 9am they will be marked as late and need to report to the front office. The infant school gates will be closed and locked at 9:05am, so please ensure you are on time.

Please support your child to be ready for school with their books and bags, ready to encourage a prompt morning routine. Children arriving late to school miss vital learning and school routines which can create anxiety as children arrive unsettled. If you find arriving at school on time challenging, please speak with staff and find solutions together.

Administration of Medicine:

- We always encourage parents to administer outside of school hours where possible.
- All medicines that are to be administered in school must be accompanied by a completed medicines form (available from the office) from the parent and/or the GP on how to administer the (dosage). This should be given to the school office.
- The label must state the following: the name of the child, the date of birth, and route of administration, intervals and amount to be given.
- It must be signed in, by the parent/carer, at the office. Teaching/support staff will not accept medications directly from children or parents/carers.
- Please remember to bring any medication back in on the first day of each term.

Individual health care plans:

- For all children who require individual specialised treatment a clear care plan must be available. This includes asthma, allergies, diabetes, epilepsy and eczema.
- The school nurse or child's GP are responsible for the content of this and a copy must be brought into school. These should be reviewed annually.

We hope the term is an exciting and successful one for all of our children.
